When I was goin' through rough times after I was released, Kevin would tell me the key was to take it one day at a time. He also told me when he was struggling with addiction, you always stood by him. He said you were the strongest person he ever knew, ever would know. So I know you can get through the next 6 months. All the grief, all the pain. And just like Kevin taught me... if you can get through that, you can make it.
